Dear Senator Wyden,

Recently, you blocked Elizabeth Darling, President Trump's nominee for Commissioner of the ACYF, canceling her original nomination by President Trump. As a result, President Trump has re-nominated Ms. Darling once again for that same position. I believe Ms. Darling is, and has been, in her nominated position as Commissioner of ACYF for President Trump in a de facto way, as a means to cover up and avoid the Faith Based sex scandal exposed by the documented evidence I have submitted to you and your committee. This illustrates the current participation of the Trump Administration and others within Ms. Darling's scandal. As a result, Ms. Darling needs to be removed immediately from ANY political appointment, consideration or the like, and a criminal investigation initiated.

Ms. Darling caused the Faith Based sex scandal in the Administration of President George W. Bush and is complicit in the criminal cover up of such along with fellow Bush appointees/now Trump appointees: **Kavanaugh, Willett and Perry**.
